Bidder 41 is ranked first for lot OSH-01. Section III – Evaluation and Qualification Criteria states (a) vi. "The Bidders with the highest Rating for each Contract Area will be recommended, *provided that in cases where the highest-rated Bidder in a given Contract Area has already been recommended for another contract Area, the second-highest rated Bidder will be recommended, and so on*".
