**Evaluation Findings and Compliance**

After a thorough evaluation, Otesa Civil Engineering (PTY) LTD emerged as the lowest substantially responsive bidder, meeting all aspects of the required compliance:

2. **Personnel and Equipment:** Verified to have the necessary personnel and equipment capacity for successful project execution.
3. **Financial Resources:** Showed adequate financial stability and resources to complete the project as specified.

The bid documentation was complete, with all calculations verified and necessary corrections applied, confirming the accuracy of the final bid price.

### **Recommendation for Award**

The Bid Evaluation Committee recommends awarding the contract for the specified works to **Otesa Civil Engineering (PTY) LTD** at the corrected bid price of **N\$ 991,362,975.85** (including VAT). The contract will cover a 24-month construction period. Otesa has demonstrated capacity and readiness, requiring no further clarification or negotiation beyond the completion of the contract agreement form, relevant annexures, performance security, and required insurances. The Bid Evaluation Committee is confident in Otesa Civil Engineering's ability to execute the project successfully and within the stipulated timeframe.
