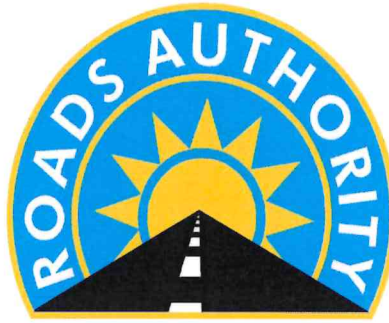

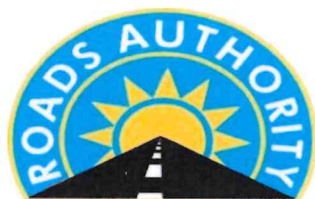

SECTION I: INSTRUCTIONS TO BIDDERS

1. Rights of Public Entity

The Roads Authority reserves the right:

- (a) to split the contract as per the lowest evaluated cost per lot; and
- (b) to accept or reject any quotation or to cancel the quotation process; and
- (c) reject all quotations at any time prior to contract award.

2. Preparation of Quotations

You are requested to quote for the works mentioned in Section III, by completing, signing and returning:

- (a) the Quotation Letter in Section II with its annex for Bid Securing Declaration, where applicable;
- (b) the Priced Activity Schedule in Section IV;
- (c) the Specifications and Compliance Sheet in Section V; and
- (d) any other attachment as deemed appropriate

You are advised to carefully read the complete Request for Quotations document, including the Special Conditions of Contract in Section VII, before preparing your Quotation. The standard forms in this document may be retyped for completion but the Bidder is responsible for their accurate reproduction.

3. Validity of Quotations

The Quotation validity period shall be (90) days from the date of submission deadline.

4. Eligibility Criteria

- (i) Qualifies as a Namibian bidder, in terms of Section 71(3) of the Act.
- (ii) To be eligible to participate in this Quotation exercise, you should submit the following documents. All copies must be certified by a Commission of Oath and must be valid at the deadline for submission
 - (a) a valid certified copy of the company Registration Certificate which outlines that bidder's principle line of business is in line with this procurement;
 - (b) a valid original/certified copy of a good Standing Tax Certificate
 - (c) a valid original/certified copy of a good Standing Social Security Certificate, a printout of a valid electronic or online document issued in terms of the Electronic Transaction Act, (Act No of 2019) will be accepted

document issued in terms of the Electronic Transaction Act, (Act No of 2019) will be accepted.

- (e) a valid certified copy of Affirmative Action Compliance Certificate, proof from Employment Equity Commissioner that bidder is not a relevant employer, or exemption issued in terms of Section 42 of the Affirmative Action Act, 1998;
- (f) duly filled in and signed Bid-securing Declaration Form;

- (h) documents must be completed in indelible ink and shall be signed by a person duly authorized to sign the bidder's documents.

Bidders are required to subscribe to a Bid Securing Declaration for this procurement Process.

6. Works Completion Period

The completion period for works shall be **1(One) Week** after acceptance and issue of Purchase Order. Deviation in completion period shall not be accepted/shall be considered if such deviation is reasonable.

7. Sealing and Marking of Quotations

Quotations should be sealed in a single envelope, clearly marked with the Procurement Reference Number, addressed to the Public Entity with the Bidder's name at the back of the envelope.

8. Submission of Quotations

Quotations should be deposited in the Quotation/Bid Box located at **Roads Authority, Corner of Mandume Ndemufayo Avenue and David Hosea Meroro, Head office, Ground floor in the Bid Box not later than 4th August 2026 at 10H00 am.**

Late quotations will be rejected.

Quotations received by e-mail will not be considered.

10. Opening of Quotations

Quotations will be opened internally by the Roads Authority immediately after the closing time referred to in section 8 above. A record of the Quotation Opening stating the name of the Bidders and the amount, will be put on the website of the Public Entity and available to any bidder on request within three working days of the Opening.

11. Evaluation of Quotations

The Roads Authority shall have the right to request for clarifications in writing during evaluation. Offers that are substantially responsive shall be compared on the basis of evaluated cost, subject to Margin of Preference where applicable, to determine the lowest evaluated quotation. Given the high volumes of bids received by the Roads Authority during bidding process. The RA has resolved to select a total of six (6) lowest priced bids to evaluate, in line with section 52(12) of the Public Procurement Act 2015(Act no 15 of 2015) as amended. Where no responsive bid is found amongst the above cited six bids, additional bids will be selected for evaluation

12. Technical Compliance

The Specifications and Compliance Sheet details the minimum specifications of the works to be carried out. The specifications have to be met, but no credit will be given for exceeding the specifications.

13. Prices and Currency of Payment

Prices for the execution of works shall be fixed in Namibian Dollars as quoted. Quotations shall cover all costs of labour, materials, equipment, overheads, profits and all associated costs for performing the works, and shall include all duties. The whole cost of performing the works shall be included in the items stated, and the cost of any incidental works shall be deemed to be included in the prices quoted.

14. Margin of Preference

. Erect new fence over 30m, including a gate entrance with (2x) 3m gates on both sides. DETAILS: 75mm x 1.6mm x 1.8m high posts, 1 post at each end of fence side, and 1 post at each side of the gate entrance. 48mm x 2mm x 2.4m stays (x4) anchored to each post for support. 48mm x 1.6mm x 1.8m high (x4) posts as interval support posts, Equally spaced over length of fence. 4 lines of steel wire 2.24mm, equally spaced over the height of 1.8m, and 3 lines equally spaced on the cap of the fence. Diamond mesh - 67mm x 2mm x 1.8m high, as fence cover, fixed to poles and steel wire with 2mm binding wire. Razor concertina wire 450mm, over the top length of the fence cap, fixed to the posts and steel wire, with 2mm binding wire. 2x gates 34mm round tube framed pre-fabricated, fitted to gate posts, on swing- open bolts. All poles anchored into holes in ground with concrete, at least 300mm deep. Concrete plinth, average 100mm above ground level and 100mm below ground level, 200mm wide, at the bottom of the fence, over the entire length of the fence. As well as 600mm wide concrete footing along the gate entrance. Apply industrial aluminum paint to all posts and gates after fence erection.
